## **2022 Department Oratorical Contest**

The Department of Iowa's High School Oratorical Contest was held Sunday, February 13, 2022, the last day of Mid-Winter Conference. Three outstanding contestants advanced from the local post to main stage at the Department Final in front of a full room and panel of 5 judges. Each contestant gave a prepared and then was assigned a 3-5-minute topic based on the US Constitution.

First place was awarded to Olivia Scott of Hiawatha, Iowa. Olivia is a Senior at John F. Kennedy High School. The title of her prepared oration is Justice Delayed is Justice Denied which focused on the 6th Amendment, the right to speedy and fair public trial. Olivia is the daughter of Rob and Sara Scott. She will compete in the National Oratorical Contest on April 22nd in Indianapolis for a chance to win a large scholarship of \$25,000 and the title of national champion. Olivia is sponsored by Hiawatha American Legion Post #735 in Hiawatha. Congratulations Olivia and best of luck.

Runner up honors go to Joseph Junker, a Senior at Van Meter High School in Van Meter. Joseph is a resident of Waukee, Iowa and was sponsored by Van Meter American Legion Post #403. Third place finish went to Charlie Moeller, a Sophomore at MOC-Floyd Valley High School. Charlie is a resident of Orange City and was sponsored by Pressman-Kosters American Legion Post #329 in Orange City.

In the history of the National Oratorical Contest, Iowa has had 3 champions: Jennifer Demmon (1986), Max Miller (2000), and Patrick Junker (2019). Since the beginning of COVID-19, the National Oratorical Contest has been cancelled two years in a row. We are hoping for this contest to get back on track at the national level, giving contestants a chance to compete and win a sizeable



scholarship. Again, best of luck Olivia and congratulations on the Department title.

We wish to thank all the volunteers who have given their time from the local to Department contests. We are grateful for your involvement and hope you will consider participating again in the Fall. It isn't too late to begin the conversation in your community regarding this program and contest.

#### **National** Commander's Tour

Paul E. Dillard was elected national commander of The American Legion on Sept. 2, 2021, in Phoenix during the organization's 102nd national convention. His theme as national commander is "No Veteran Left Behind."

He first joined The American Legion in 1969.

A native Texan, Dillard graduated from Whitesboro High School in 1965 before joining the U.S. Navy and serving in Vietnam through four campaigns including the Tet offensive. He later received an honorable discharge as a radarman second class petty officer from the Navy Reserve before attending Grayson County Junior College and East Texas State University.

Dillard worked several years in the manufacturing business as an engineer, plant manager and director of manufacturing in Tennessee. Upon returning to Texas, he accepted a sales representative position with Sherman Foundry and became its airplane pilot. A career change was made when he and his wife, Donna, began their family and he entered the insurance business specializing in employee benefits and later forming Dillard & Gann Insurance.

As a paid-up-for-life member of American Legion Post 265 in Lake Kiowa, Texas, Dillard served as post commander, vice commander, adjutant, and judge advocate. He coached

American Legion Baseball for more than 10 years and served as his post's Boys State chairman.

Dillard served the 4th District as commander and vice commander and served the department as sergeant-at-arms, Membership & Organization chairman, National Security chairman, Uniformed Organization chairman, Board of Trustees chairman, and he served on the Finance Committee and the Long-Range Planning Committee. He was elected as Department of Texas commander in 2007.

On the national level, Dillard has served as Alternate National Executive Committeeman, consultant to the Insurance Committee, Distinguished Guest Committee, Children & Youth Committee, and Media and Communications Council. He has served as chairman of the Foreign Relations Committee, chairman of the Veterans Employment & Education Commission and chairman of the Legislative Commission. He was elected as national vice commander in 2013.

Dillard married Donna in 1983. They have two sons, William and his wife Allison, and Jonathon and his wife Karri, and two grandsons Jarrett and Lukas. All are members of the American Legion Family. Donna has been an active and dedicated member of The American Legion Auxiliary for several years and has served in numerous positions of leadership at all levels of the organization, including department president in 2017-2018.

Mid-Winter was full good training sessions and

much information received from the committees and general sessions. As usual, there was much to discuss and learn around the hospitality rooms

and tables. So, everyone that attended Mid-Winter, I want to thank you for your "Individual Obligation to the Community, State and Nation."

My year is flying by so fast. I'm 7 months into my year as your Dept. Commander and it has been very rewarding, meeting many new faces and seeing some great things developing at many posts. As I visit the posts, I do my best to remember to "INCULCATE". It's the posts that never send a representative to a District Conference, Mid-Winter or State Convention that I need to reach out to I'm preaching to the choir at these events because they made the commitment to attend and doing the things we need to do for "MEMBERSHIP".

Membership is everyone's responsibility and needs to be taken seriously because it is serious. Without it we are no longer a functioning organization. We are doing well in the national standings, but we can do better.

We've ranged from 13th, early in Nov., and have been in 2nd a couple of times lately. As of Feb. 6th, we are in 4th and only .51% out of 1st place. That equates to less than 200 members, very doable. We have about 5152 members that have not renewed and if each individual post would take pride in doing that and show they value their members we would be nearly at goal. There are 729's still out there that need a post plus many veterans who need to become members. I thank the posts that have made 100% and I'm asking the remaining ones to put forth the extra "EFFORT and PRIDE" to reach that goal. Reach out to your District Officers for assistance, they are there to help.

If we put the "EFFORT and PRIDE" into this, we can make the national challenge of 103% in membership with 90% retention. We are at 86.6% of retention. To me there is "NO REASON, ONLY EXCUSES". Enough on my "INCULCATING".

It has been a great pleasure to visit posts around the state to see the good things they're doing. I was honored to attend the Victor Post in Dec. for the presentation of several Quilts of Valor and the individual reading of the 5th Grade Flag Essay. I think there was well over 120 people in attendance and was a wonderful evening. On Feb. 5, I had the honor of presenting a Sons of the American Legion Charter to the newly formed Squadron at the Manly Post. It truly was a wonderful day for the post, and I loved the enthusiasm that was visible that day. It was well attended and had a room full. I finished the day with a visit to Williamson Post #719 for their fundraiser for the Honor Flight. A long day, but well worth while!

I was fortunate to attend 2 of the 3 Area Oratorical Contests, Van Meter and Carroll, impossible to make 2 on the same day as scheduled. I heard 6 outstanding speeches and they are all winners in my mind. If you didn't make it to Mid-Winter on Sunday morning for the finals of the Oratorical Contest, you missed one of our great youth programs and a good education on the Constitution.

I know I've met several legionnaires in my travels and have been asked when I will visit their Post. If you have an event coming up or would just like a visit at your Post, please let Ann in Headquarters know and if my schedule fits, I would love to come and visit.

# **Department Service Officer**Shane Pankonen

Emergency Treatment and Care outside of VA Medical Centers/Clinics

If the need for emergency care ever arises, it may not always be possible to get to a Veteran Administration (VA) Hospital or Clinic. If you believe your life is in danger if you do not seek immediate medical attention, call 911 or go to the nearest Emergency Department. When an emergency arises, and it is not feasibly possible to get to a VA medical center or other federal medical facilities, you do not

need prior approval to call an ambulance or seek care

at an Emergency Department. We as well as the VA

encourage all Veterans to seek immediate care in the event of an emergency.

You, a family member, or a staff member of the Hospital from which you have been admitted should contact the nearest VA within 72 hours to inform them of your admission. Failure to report admission within 72 hours can possibly impact your eligibility for the VA to cover your medical costs. Emergency treatment is only covered until you can be safely transferred to a VA medical facility. If it would arise that the nearest VA facility could not accept your transfer of care, make sure that they have documented this in your chart.

To be eligible for Non-VA treatment, you must be first be enrolled in the VA healthcare system. Failure to report your admission within 72 hours will not automatically result in a denial of the emergency care claim, however, it may affect your eligibility to have your claim paid by the VA. If you refuse to be

transferred to a VA facility or federal facility, after your condition has been stabilized, you may be liable for the cost of care by staying at that facility.



### **ALAMIS for 2023**

As has been shared previously, new user rates for ALAMIS access will be going into effect in 2023. Please note that we will not be charging these rates until January 2023 at the National level. This means you will receive invoices for your ALAMIS from Department starting August 1st that will be due October 20th. This way we can have all funds available for the National bill for ALAMIS by January 1st.

The new fee structure will be:

Unit Full Access (i.e. can pay dues) - \$20.00 per user—This is new, we can starting adding Units that want to do this starting July 2022. You will need to notify Department for a change in access.

Unit Write Access - \$15.00 per user

Unit View - \$10.00 per user (This remains the same)

\*\*\*Units can have up to 2 users\*\*\*

Again, this will go into effect starting August 1st, 2022, and must be paid by October 20th. You will receive an invoice for your normal \$10 VIEW ONLY access, if you want to get Write Access or Full Access, we will need you to pay accordingly, and you can write your information or type of access on your invoice. I will include this information in multiple more notifications and on the invoices themselves.

Update! Units Paying Dues Pilot Program:

The units paying dues pilot program has been going very well! We will open up the option for any unit to have Unit Full access (with department approval) starting in July 2022 when we open the billing for the 2023 membership year. Unlike other ALAMIS access levels, these members requesting Unit Full access will be required to attend a virtual training with ALA NHQ membership staff. More information on this access will be sent out to departments in late spring. Any unit signed up for Unit Full access starting in July 2022 will not be charged for their access until January 2023 to give units an opportunity to "test drive" this access to see if they want to continue using it.



## **Auxiliary Emergency Fund**

Auxiliary Emergency Fund, also known as AEF, is members helping members. Whether it's due to a natural disaster or a financial hardship; a member with the current year's dues and the previous two years' dues paid may be eligible. Please check the National American Legion Auxiliary website for more details and applications. Be sure that you meet all the criteria and submit the application as well as all required paperwork when submitting your application. How are you doing with the AEF challenge? Have you sent any donations in? I understand some members are donating money every month, some are keeping track and donating it "all" at the end, and some are donating what they can. ## 2021-2022 Consolidated Post Reports (CPR)

The American Legion's 2021-2022 Consolidated Post Report (CPR) will be mailed to each post mid-March. The CPR, which documents every activity a post fulfills in a 12-month (June 1-May 31) reporting period, is due to Department Headquarters no later than June 15, 2022. If you are post still using the paper form, send the white and yellow copy to Department Headquarters. Keep the pink copy for your post records.

Whether it's providing funeral honors, sponsoring youth to attend a Legion program, conducting fundraising efforts or more, your post has something to report. A fillable 2021-2022 CPR form can be accessed through the Department's website www.ialegion.org/cpr and submitted by mail.

Preferably, the CPR can easily be completed and submitted through myLegion.org; it's located under "Post and Department" options. The online form is the Legion's preferred method both on a state and national level, so posts are highly encouraged to complete them online.

After completing the form, click on the "Submit" button to send the report to National Headquarters; a copy will automatically be sent to Department Headquarters, as well. Online submission will be available at myLegion.org through July 1st, the cutoff for receipt of forms at National Headquarters. Completing the online form allows national to update the state's tally immediately, ensuring an accurate account.

Finally, any post desiring to qualify for Department Awards for their CPR must provide a concise but well written narrative of the post's involvement. Only posts whose CPRs accompanied by a narrative will be eligible for Department Community Service and Children & Youth Awards.

## **Buddy Checks**

Taking care of our fellow veterans is a primary mission of The American Legion. We fulfill this mission in many ways. Our Service Office assists veterans with their claims for VA benefits, with obtaining VA health care, with discharge upgrades, and many other services. The American Legion advocates for veteran's legislation on the national and state levels. Members of The American Legion volunteer at VA hospitals and clinics and the Iowa Veterans Home. Posts loan medical equipment such as wheelchairs, walkers, crutches and even hospital beds to veterans. Serving our fellow veterans is not just what we do, it is

At the National Executive Committee meeting in May of 2019, The American Legion passed Resolution 18, calling for Buddy Checks to be conducted Legion-wide on the weeks of The American Legion's Birthday, March 15, and Veterans Day, November 11. However, American Legion posts are encouraged to perform Buddy Checks whenever it works best in their own community.

The purpose of the Buddy Check is to reconnect with veterans who may

need assistance but don't know where to go or who to ask. The important part is to reach out to veterans in your community to let them know you care and help where possible.

Conducting Buddy Checks is not a difficult process. Gather up a team to call or personally visit members and former members of The American Legion. Get a list of members and former members by using your roster or from mylegion. org. Divide up the call list among your team members. Start making connections – either from a quiet place inside the post or from your home - to see how the members and former members are doing. Ask if they need anything and invite them to any event or activity planned for your post. Thank the member or former member in the beginning and at the end of your call. If the member or former member wishes to renew, be sure to have your post's payment procedure at your fingertips, the address to send a check or offer to stop by in person to pick it up. Give the member contact information in case the member or former member can't take the call or needs anything in the future.

Our last report to you in the Winter issue of the lowa Legionnaire spoke of the growth in the finances of the Foundation, both from the generosity of our donors and the expertise of our financial advisers at



Regions Bank. As anyone who has retirement funds invested, the last quarter has told a different story as far as investment growth is concerned.

Thanks to the investment policy of the Foundation that 60% of the principal is invested in fixed income securities, that principal has not suffered unduly. As of January 31, the Foundation's value had declined by 2.5% much less than many other investments. The expertise of our Advisers at Regions is also responsible for a smaller drop than might be expected.

This is the time of the year when the generosity of all our donors really pays off. We have updated the grant application and posted it to the lowa website. Along with that we will notify all of last year's applicants that we will be accepting applications for this year.
